This was AV MACH2 Kiahaus' Diamond Rio CDX, HIC, CGC, TDInc's, path to the 2004 GSDCA National Specialty Agility Victor and High In Trial (HIT) awards.

Standard & Excellent Jumpers (JWW) awarded from the combined scores from both Wednesday & Thursday's trials. One hundred points is awarded for a clean run. Ties are broken by the fastest combined run times. A total of 15 dogs competed for this title.

For the Agility Victor/Victrix award, the winning dog had to have the Highest Combined Score in Excellent

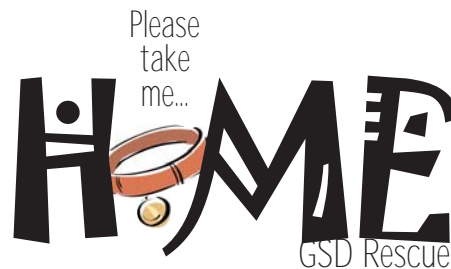

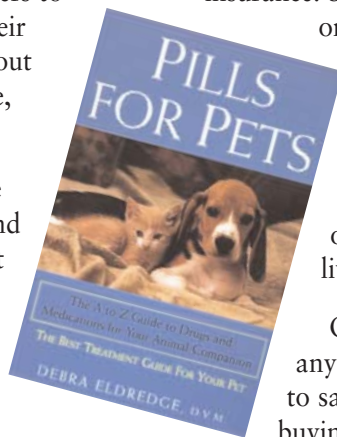
Pills for Pets by Debra Eldredge, D.V.M.

Pills for Pets is a comprehensive, easy to use listing of prescription and over the counter drugs - including cautions, possible side effects, and drug/food interactions. Deb Eldredge makes it very clear that the information in her book is to

allow pet owners to supplement their knowledge about veterinary care, not replace it.

Dr. Eldredge gives advice and cautions about homeopathic remedies, herbal treatments, vitamin and nutritional supplements; all of which are becoming very popular with pet owners. Her book also helps pet owners in choosing the right veterinarian and pet



insurance. She also touches on emergency first aid and how to provide long-term nursing care for animals, as many of our pets are living longer.

Rio, Agility Victor *continued from page 1*

For the High In Trial award, the winning dog had to be the highest scoring dog from Regular Standard class with the highest averaged combined score from Wednesday & Thursday's trials. This award is open to all dogs competing, all levels (Novice, Open & Excellent) in the Standard class. A total of 30 dogs were entered to compete for this title.

Rio placed second in his Jumpers run and first in his Standard run on the first day for a total of 200 points. There were four other dogs that also qualified in both runs on the first day (with 200 points). The first day's combined times found Rio in first place by the slimmest of margins — .61 of a second. A very slim lead, indeed.

On the second day, three of the five dogs failed to qualify in the first run in the morning. One other dog, Otto, who ran before us qualified in his run so we had to run clean in order to continue our quest. We ran

clean and took a another first place in the process. Otto again ran before us and ran clean in his Jumpers run in the afternoon. So, again, we had to run clean in our Jumpers run in order to win the title. We did, and took a Third place in Jumpers in the process.

Both Rio and Otto had 400 points for the two days. Rio's combined time for his four clean runs was 163.96 seconds. Otto's combined time for his four clean runs was 210.75 seconds. Rio's time was an amazing 46 seconds faster than Otto.

His two first-place finishes in his Standard runs (200 points) and fast times (combined 33 seconds under standard course time), earned him the High In Trial award over the other 29 dogs entered.

Rio is 7 1/2 years old. We are very proud to say that we bred him, and his sire as well. He is the first ever MACH GSD bred by,

trained by and handled by his owner.

Rio is a high drive, extremely bright dog that is talented in other areas as well. He earned his CD and CDX titles in 3 trials each. His scores, 195, 196 & 197, in the Open class, would have earned him a Dog World Award (if they gave them anymore).

Rio enjoyed herding (HIC) and also took his class in the two conformation shows in which Jerry showed him. And he is amazingly intuitive when he visits facilities as a therapy dog.

Rio will be competing in the 2005 AKC Agility Nationals and is going to keep working towards his MACH3. It is not so far away. After that he might try tracking (maybe a VCD title?) and perhaps go back and see how far he can go in Obedience, a UDX or an OTCH would be a nice way for him to start his retirement years. •
