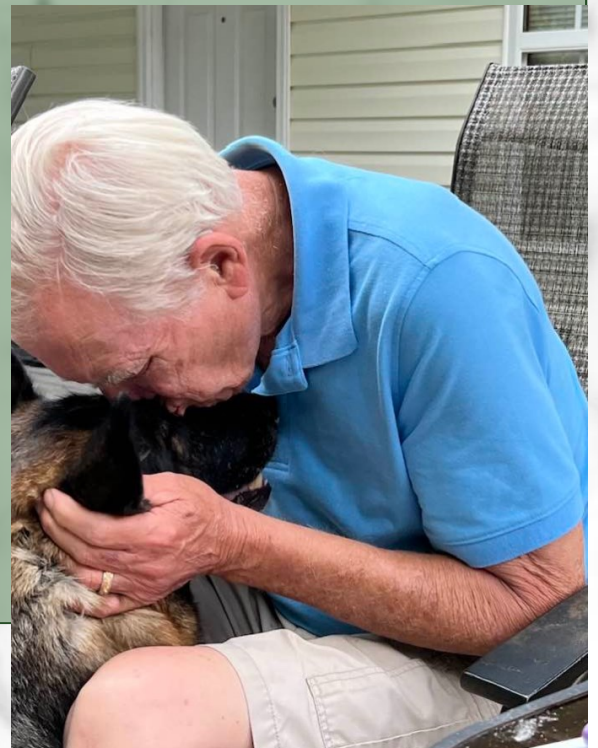

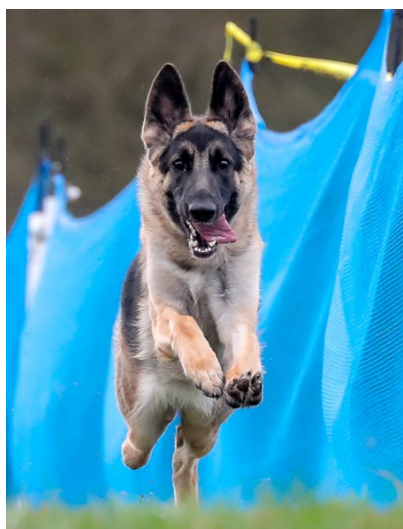

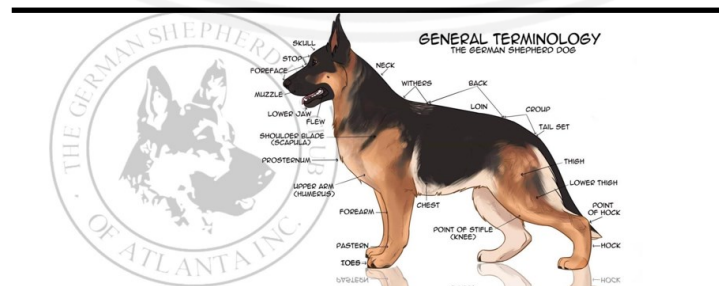

Articles of Incorporation Of The German Shepherd Dog Club of Atlanta, Inc.

- I. The name of the corporation is: "THE GERMAN SHEPHERD DOG CLUB OF ATLANTA, INC."
- II. The corporation shall have perpetual duration.
- III. The corporation is organized for the following purposes:
 - a. To encourage and promote the intelligent and selective breeding of purebred German Shepherd dogs and to do all possible to bring their qualities to perfection and encourage scientific research for the improvement of the breed.
 - b. To do all in its power to protect and advance the interests of the breed by upholding the standard of the German Shepherd dog as described by the American Kennel Club and by encouraging members to support competition at conformation dog shows and obedience trials through entries, sportsmanship, and other means of suitable nature.
 - c. To educate the public generally as to the uses, habits, characteristics, advantages, training, care, companionship and treatment of German Shepherd dogs.
 - d. The corporation is not organized and shall not be operated for pecuniary gain or profit. No part of the property of the corporation and no profit if its net earnings shall inure to the benefit of the director or any other private individual. The corporation shall never be authorized to engage in a regular business of a kind ordinarily carried on for profit or in any other activity except in furtherance of the purposes stated above, for which the corporation is organized. The corporation shall never be authorized to engage in any business which may preclude its exemption under the Internal Revenue Code of 1954, Section 501 (c), as amended.
- IV. The affairs of the corporation shall be managed by a Board of Directors. The method of election of directors shall be as determined by the by-laws of the corporation.
- V. The initial registered office of the corporation created.
- VI. The initial Board of Directors shall consist of nine (9) members.
- VII. Membership in the corporation shall be determined as follows:
 - a. A prerequisite for membership is an interest in the German Shepherd dog with expressed intention to uphold the intents, purposes, and objects of the corporation as set forth in these Articles of Incorporation. Any worthy person, sixteen (16) years of age or older, may apply for membership as provided in the by-laws.
 - b. There shall be four classes of membership in The German Shepherd Dog Club of Atlanta, Inc.: (1) active; (2) associate; (3) life; (4) honorary. Qualifications for the various classes of membership are provided in the by-laws.





Who are We?

The German Shepherd Dog Club of Atlanta, Inc. is a nonprofit organization chartered in Georgia in 1974. Our club objectives are to uphold the intents and purposes as stated in the Articles of Incorporation, and to conduct sanctioned and licensed specialty shows and all AKC events for which the Club is eligible under the rules of the American Kennel Club. Further, to conduct approved GSDCA -WDA events under the authority, rules and regulations of the German Shepherd Dog Club of America Working Dog Association, Inc.



Our purpose is to advocate for the breed; through programs and activities members learn about all aspects of the German Shepherd Dog, including mental and physical development; the breed standard, working ability, breeding, care and rearing of puppies.



The GSDC of Atlanta is one of the many registered clubs in America who are part of the breed parent club, the German Shepherd Dog Club of America (GSDCA). These clubs are split into 7 different regions, where we reside in the Southeast Region.

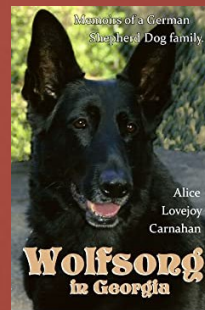
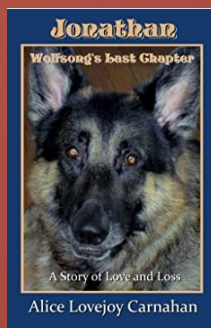
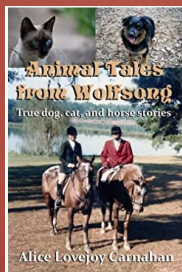

House Resolution 1368

A RESOLUTION

1 Commending the benefits and contributions of purebred dogs and recognizing May 1, 2024,
2 as Purebred Dog Day in the State of Georgia; and for other purposes.

3 WHEREAS, dedicated individuals in Georgia breed dogs to develop unique predictable
4 characteristics that enable dogs to excel in a wide range of beneficial areas; and

5 WHEREAS, purebred dogs are living legacies of the cultures that created them, and
6 historically these dogs worked alongside their people and provided them companionship; and

7 WHEREAS, the service of these breeds continues as they work alongside humans and
8 provide inestimable companionship as guide dogs, service dogs, conservation dogs, livestock
9 guardians, search and rescue dogs, earth dogs, police dogs, canine soldiers serving by the
10 sides of our military men and women, and guardians of family, home, and hearth; and

11 WHEREAS, purebred dogs have been of enormous help to medical science, serving as
12 models for many heritable human diseases, playing a role in humanity's understanding of the
13 human and canine genomes, and benefitting pharmaceutical research and development; and

14 WHEREAS, purebred dogs are working dogs, serving as avalanche dogs, trackers and
15 trailers, herders, controllers of vermin, water rescuers, carting and sled dogs, retrievers,
16 protectors, hunters, and bird dogs, and they are always the heartbeat of a companion near and
17 dear to humans; and

18 WHEREAS, all dogs should be valued whatever their ancestry, but the purpose-bred dog and
19 the predictability of its breed should be cherished and preserved; and

20 WHEREAS, each breed is incredibly etched in the history of the culture that created it, just
21 as surely as that culture's music, art, and language, making it abundantly fitting that we
22 recognize purebred dogs.

23 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
24 the members of this body commend the benefits and contributions of purebred dogs and
25 recognize May 1, 2024, as Purebred Dog Day in the State of Georgia.

26 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives is authorized
27 and directed to make appropriate copies of this resolution available for distribution to the
28 public and the press.

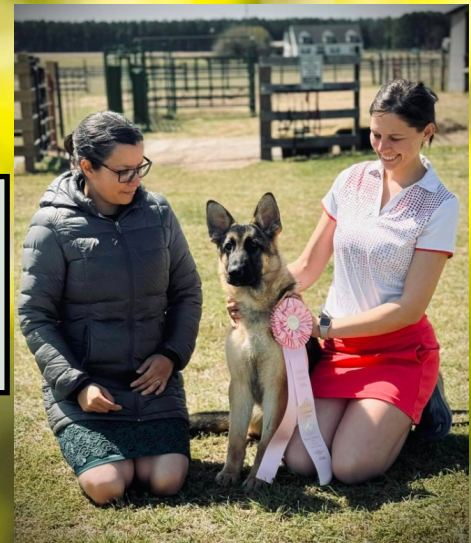

Club's Breeder Referral

I offer referrals towards our club members first. If I don't know of any club puppies, I offer names of others local to our area that I know offer a good dog and will stand behind their puppies. And I give no preferences to anyone – I try to be as unbiased as possible.

The below questions are based on my experience as a breeder and owner. My first dog purchase in 1968 was an inbred father/daughter litter, and he had the most titles of any dog in his 5-generation pedigree – a CDX. I will credit him with establishing my love of the breed and we had a lot of fun.

I joined the GSDC of Atlanta in 1972, moved out of the area and continued in obedience with my dogs until we moved back to Atlanta in 1984. I rejoined the club in 1988 after my old dogs had died and I purchased a puppy from Caralon Kennels.

I've had dogs that were shown in conformation, obedience, rally, herding, FastCat, and dabbled in tracking and nose work.

*Members, keep me in the loop!
Let me know if you're having
puppies, planning a litter, or
have a dog you want to place.*

Questions that I ask callers

Have you ever owned a GSD before

What area of town do you live in or does it matter how far away the puppy is located

Do you have a fenced yard or what is your exercise plan

Do you want a puppy or an older dog

What do you want to do with your dog – pet, show, performance, etc.

How did you find out about the club

Questions I advise callers to ask the person with puppies. Callers frequently know of "puppies" from a friend knows someone who has a litter.

What health screenings do the parents have, i.e. OFA, DM, etc.

Make sure you meet the dam of the puppies, if you don't like her leave

How old is the dam

Do they have both parents on site

I tell everyone that calls – your dog needs a job – if you don't give him one, they will make their own job.

Everyone has their own hot buttons and these are mine. I've been fortunate to have great mentors over the years. Scootie Sherlock of Caralon Kennels, was my first mentor and was always there for me even after I no longer had a dog from her bloodlines. Find yourself a mentor and then listen.

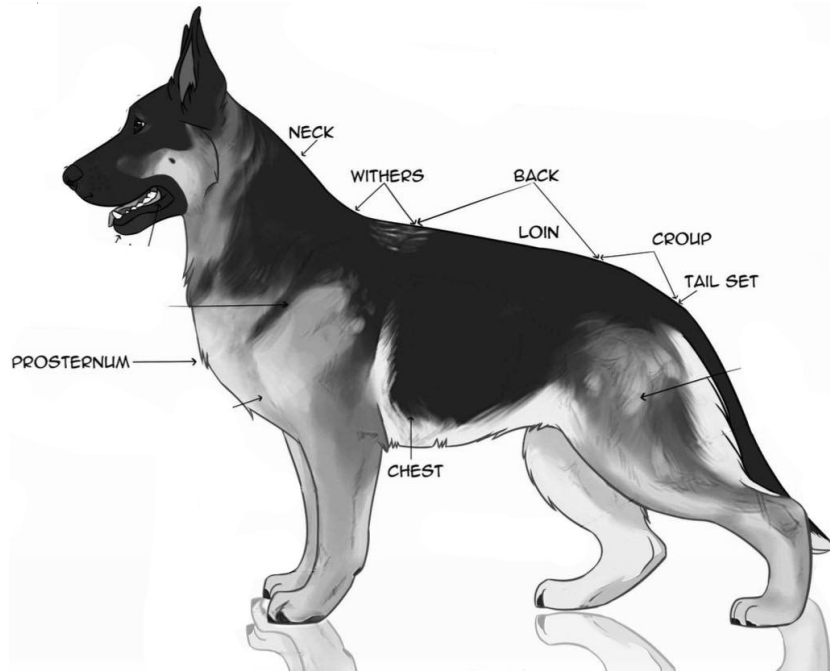

Neck, Topline, Body

BREED STANDARD

The neck is strong and muscular, clean-cut and relatively long, proportionate in size to the head and without loose folds of skin. When the dog is at attention or excited, the head is raised and the neck carried high; otherwise typical carriage of the head is forward rather than up and but little higher than the top of the shoulders, particularly in motion.



Topline— *The withers are higher than and sloping into the level back. The back is straight, very strongly developed without sag or roach, and relatively short. The whole structure of the body gives an impression of depth and solidity without bulkiness.*

Chest— *Commencing at the prosternum, it is well filled and carried well down between the legs. It is deep and capacious, never shallow, with ample room for lungs and heart, carried well forward, with the prosternum showing ahead of the shoulder in profile. Ribs well sprung and long, neither barrel-shaped nor too flat, and carried down to a sternum which reaches to the elbows. Correct ribbing allows the elbows to move back freely when the dog is at a trot. Too round causes interference and throws the elbows out; too flat or short causes pinched elbows. Ribbing is carried well back so that the loin is relatively short. Abdomen firmly held and not paunchy. The bottom line is only moderately tucked up in the loin.*

Loin *Viewed from the top, broad and strong. Undue length between the last rib and the thigh, when viewed from the side, is undesirable. Croup long and gradually sloping.*

Tail bushy, *with the last vertebra extended at least to the hock joint. It is set smoothly into the croup and low rather than high. At rest, the tail hangs in a slight curve like a saber. A slight hook- sometimes carried to one side-is faulty only to the extent that it mars general appearance. When the dog is excited or in motion, the curve is accentuated and the tail raised, but it should never be curled forward beyond a vertical line. Tails too short, or with clumpy ends due to ankylosis, are serious faults. A dog with a docked tail must be disqualified.*

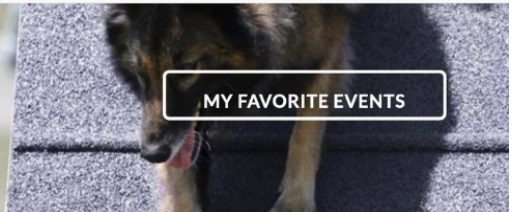

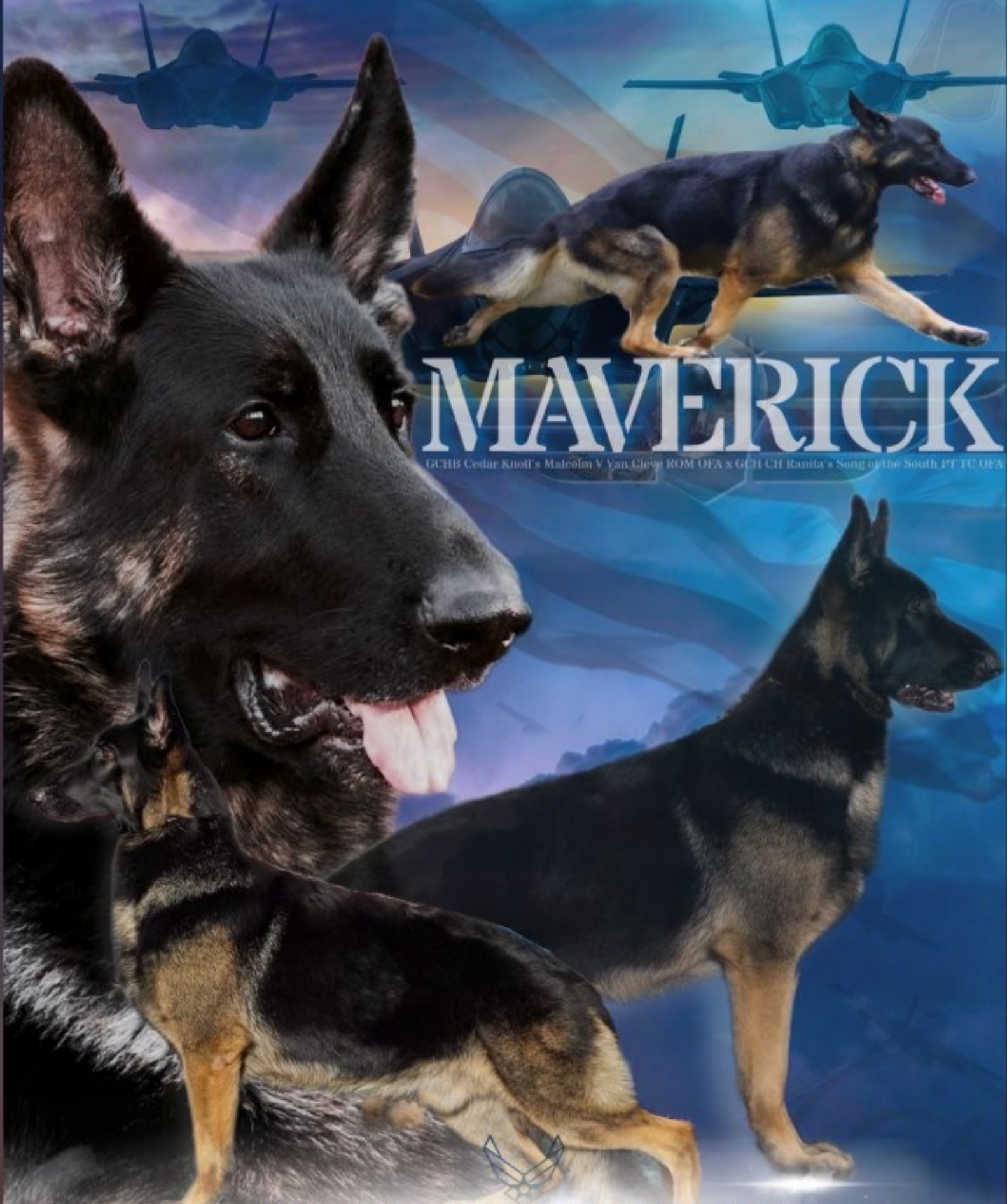
